

## OFFICIAL RULES FOR THE “THE POWER OF FRIENDSHIP” SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**DATES OF PROMOTION:** The Saputo Dairy Foods USA, LLC The Power of Friendship Sweepstakes (the “**Sweepstakes**”) starts at 4:00:00 PM Eastern Time on Wednesday, November 8, 2017, and ends at 11:59:59 PM Eastern Time on Tuesday, December 12, 2017 (the “**Entry Period**”).

**ELIGIBILITY:** Sweepstakes is open to all legal US residents physically residing in the 50 United States and District of Columbia who are 18 years of age or older, as of Wednesday, November 8, 2017, and have reached the age of majority in the state of residence. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live; or persons living in same household, whether related or not) of Saputo Dairy Foods USA, LLC (the “**Sponsor**”), US Sweepstakes & Fulfillment Co. (the “**Sweepstakes Administrator**”), their affiliated companies, advertising and promotion agencies, and any other entities directly associated with this Sweepstakes (collectively, “**Released Parties**”) are not eligible to participate, enter or win. Void in Puerto Rico, U.S. territories, U.S. Military installations in foreign countries and where prohibited or restricted by law.

This Sweepstakes is limited to one (1) Entry (as defined below) per person/e-mail address during the Entry Period. Winning the Grand Prize, as defined below, is contingent upon fulfilling all requirements set forth herein.

**HOW TO ENTER:** During the Sweepstakes Period, log on to [www.PowerOfFriendshipSweeps.com](http://www.PowerOfFriendshipSweeps.com) to link to an online Sweepstakes entry form (the “**Entry Form**”). Fill out the Entry Form by providing your first name, last name, and e-mail address. Once all necessary fields are completely filled out, submit your Entry Form by clicking the “Enter Sweepstakes” button. A thank-you message will be displayed to confirm that your Sweepstakes Entry Form was successfully sent. Each entrant who fully completes the Entry Form will receive one (1) entry into the Sweepstakes (hereinafter referred to as an “**Entry**” or “**Entries**”). Entrants must complete the entire Entry Form in order to successfully enter into the Sweepstakes. If the Entry Form is aborted before it is complete, the entrant will not be deemed to have made a qualifying Entry.

**LIMITATIONS ON ENTRIES:** One (1) Entry per person per e-mail address during the Entry Period. Incomplete Entries and Entries not complying with these Official Rules are subject to disqualification. No correspondence regarding Entries will be acknowledged or entered into with entrants.

**PRIZE:** One (1) grand prize winner (“**Grand Prize Winner**”) will receive one (1) \$1,000 Pre-paid Gift Card. The Approximate Retail Value (“**ARV**”) of the Grand Prize is **\$1,000**.

All federal, state and local taxes, including, but not limited to, any taxes imposed on the income of the Grand Prize Winner as a result of winning the Grand Prize and all other expenses not specifically mentioned herein as part of the Grand Prize are solely the responsibility of the Grand Prize Winner. Grand Prize winner will be required to furnish his/her Social Security Number for the sole purpose of preparation of tax forms as required by law.

Grand Prize is non-transferable and no cash redemption or substitution allowed, except at Sponsor’s sole and absolute discretion. Sponsor reserves the right at any time to substitute the Grand Prize for any reason with a prize of equal or greater value, including, without limitation, at the Sponsor’s sole discretion, a cash award.

Pre-paid Gift Card will not be replaced if lost or stolen. Pre-paid Gift Card usage is subject to the issuing company’s terms and conditions, including expiration dates.

**DRAWING/ODDS:** One (1) potential Grand Prize Winner will be determined through random computer generation methodology on or about **Friday, December 15, 2017**. Odds of winning depend on the number of eligible entries received during Entry Period. Many will enter, only one will win.

**NOTIFICATION OF WINNER:** The Sweepstakes Administrator will attempt to notify the potential Grand Prize Winner by e-mail, using the email address provided on the Entry Form within ten (10) days of the drawing. If a potential Grand Prize Winner cannot be reached within seven (7) days of initial attempt and/or fails to respond to any notification attempt within seven (7) days, or if any attempted notification or prize delivery is returned as undeliverable, the Prize will be forfeited. Sponsor may select an alternate potential Grand Prize Winner in his/her place at random from all eligible Entries received. Only two (2) alternate winners may be determined through this process, after which the prize may remain un-awarded.

The Grand Prize will be awarded within approximately forty five (45) days after the winner is

verified. By accepting the Grand Prize, Grand Prize Winner consents to the use of his/her name on the list of winners.

In the event of a dispute regarding the identity of an individual who actually submitted an online Entry, the Entry will be deemed submitted by the Authorized Account Holder of the e-mail account provided in the Entry Form. "**Authorized Account Holder**" is defined as the natural person who is assigned to an e-mail account by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Potential Grand Prize Winner may be required to show proof of being the Authorized Account Holder.

EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. THE PARTIES HEREBY WAIVE THEIR RIGHT TO JURY TRIAL WITH RESPECT TO ALL CLAIMS AND ISSUES ARISING OUT OF OR RELATING TO THIS AGREEMENT WHETHER SOUNDING IN CONTRACT OR TORT, AND INCLUDING ANY CLAIM FOR FRAUDULENT INDUCEMENT THEREOF.
